

Legitimate Interests Assessment M217S V.2

Considerations of LTDP for this assessment...

This assessment is utilised to establish *'legitimate interests'* as the Controller's lawful basis to process patient data for the purpose of providing dental care. This includes contacting patients for recalls, reminders, treatment plans and estimates by post and telephone. LTDP gains written consent from patients to send emails or text messages for these purposes. See the MDDUS guidance <u>here</u> and the Communication Consent Form (M 217RA).

The <u>Data Protection Network</u> provides some useful information about how legitimate interests may be used as a lawful basis to carry out marketing. *CODE cannot advise on using legitimate interests as a lawful basis for marketing*, as the legal issues are too complex and there is no official guidance yet. For business-to-consumer marketing, members will have to take into account ePrivacy legislation and the new Data Protection Act.

GDPR says: "The legitimate interests of a controller, including those of a controller to which the personal data may be disclosed, or of a third party, may provide a legal basis for processing, provided that the interests or the fundamental rights and freedoms of the data subject are not overriding, taking into consideration the reasonable expectations of data subjects based on their relationship with the controller. Such legitimate interest could exist for example where there is a relevant and appropriate relationship between the data subject and the controller in situations such as where the data subject is a client or in the service of the controller"

The legitimate interests assessment is based on a 3-stage process:

- 1. Identify what your legitimate interests are for processing data
- 2. Decide if this way of processing data is necessary to achieve your aims and if there is a less privacy intrusive way to achieve them
- 3. Carry out the balancing test, to weigh up the balance between the interests of your company and the interests of the individual, not forgetting to include any benefits to society. It is necessary to include the risks of carrying out the activities and the risks of not carrying out the activities. Prevention and public health for example

It is also necessary to include the safeguards to reduce the impact on privacy and in particular any measures that you take to mitigate the risks.

Finally, after assessing the risks and benefits we detail our conclusion, based on the Interests, benefits, the risks, the safeguards and mitigating measures, as to whether or not there is a legitimate basis for processing data.

Can the processing affect the interests or the fundamental rights and freedoms of the individuals	Not as far as we are aware
What are the risks of not processing the data to the practice	If we do not continue to deliver excellent and preventative dental treatment this could result in professional disciplinary action, negligence claims or the closure of the practice
What are the risks of not processing the data to the individual	Regular attendance, prevention and timely treatment according to the patient's individual need is the best way to prevent and treat dental disease. Untreated dental disease can cause pain, suffering, limitations in social functioning and is associated with many health problems
What are we doing to mitigate risk of processing the data	We ensure that the information collected kept to the minimum necessary and is retained for the minimum amount of time. We have robust confidentiality policies and procedures, including Information Governance Procedures (M 217C) and the Data Protection and Information Security Policy (M 233-DPT). The team are regularly trained on confidentiality and information governance at practice meetings

Can the individual object to processing data or request its deletion	The patients can object to processing their data if they inform us that they no longer want to be a patient at the practice. We cannot delete clinical records unless the patient has left the practice and our retention period has lapsed according to our Record Retention rules (M 215). If we are informing members of the public who are not patients or who are past patients, about dental prevention and healthcare they can object to the processing of their data. People who have never been patients can request deletion of their data

Based on my assessment, Nick Williams who is the Data Controller, has a legitimate interest to process personal data for the purpose of providing evidence based dental care and prevention. The risks to the individuals are minor, they are mitigated by our policies, procedures and training.			
Our assessment is that the risks of processing personal data are much outweighed by the benefits. It is the interests of the person to receive timely preventative, evidence based dental care. The lack of dental care has a negative impact on the health, well-being and functioning of the individual and society
